ORDINANCE NO: 38-21

AN ORDINANCE AMENDING ORDINANCE NO. 38, AND ALL  
AMENDMENTS THERETO, PROVIDING FOR THE OPERATION  
OF PUBLIC SEWERS AND SEWAGE SYSTEMS WITHIN  
THE TOWNSHIP OF DAVISON, CONNECTIONS THERETO AND  
RATES AND CHARGES FOR CONNECTIONS THERETO AND  
USE THEREOF; PROVIDING FOR PENALTIES FOR VIOLATION  
AND PROVIDING FOR OTHER RELATED MATTERS

The Township of Davison Ordains:

The following sections of Davison Township Ordinance No. 38, as amended, shall be amended as follows:

SECTION 1

ARTICLE VII. SEWAGE TREATMENT CHARGES

Section 2 is hereby amended to read as follows:

Where the premises are served by water which is metered, the monthly charge shall be \$7.00 per REU per month plus water consumption and shall be computed at the rate of:

**County Charge:** \$1.66 per 100 cubic feet in addition to a monthly connection charge of \$3.41 per REU per month in accordance with the County Table of Unit Factors.

**Township Charge:** \$3.59 per REU per month (\$10.77 per quarter) in accordance with the County Table of Unit Factors.

For premises not served by water which is metered, the monthly charge shall be a charge of \$27.73 per REU per month and shall be computed at the rate of:

**County Charge:** \$24.14 per REU per month (\$72.42 per quarter) in accordance with the County Table of Unit Factors.

**Township Charge:** \$3.59 per REU per month (\$10.77 per quarter) in accordance with the County Table of Unit Factors.

Rates for service are applied when bills are rendered.

SECTION 2

Users assessed more than ten REUs in accordance with the County Table of Unit Factors may request evaluation of their use pursuant to exhibit A of this amendment.

SECTION 3

All other provisions of this Ordinance, including those provisions that provide penalties for the violation of this Ordinance, shall remain in full force and effect.

SECTION 4

This Ordinance amendment shall become effective thirty (30) days after publication.
