**AN ORDINANCE AMENDING ORDINANCE 39, AS AMENDED  
TO PROVIDE FOR THE CONNECTION OF PREMISES TO THE  
GENESEE COUNTY WATER SUPPLY SYSTEM NUMBER TWO,  
IN THE TOWNSHIP OF DAVISON, GENESEE COUNTY,  
MICHIGAN; TO PROVIDE FOR THE IMPOSITION,  
COLLECTION AND ENFORCEMENT OF FEES FOR  
CONNECTION THERETO OR AVAILABILITY THEREOF AND  
FOR CHARGES FOR WATER SUPPLY SERVICE THEREFROM;  
AND TO PROVIDE FOR OTHER MATTERS RELATIVE TO SAID  
SYSTEM AND TO THE USE THEREOF**

The Township Board of the Township of Davison Ordains:

**SECTION 1**

The following sections of Ordinance No. 39, Section 7.01, as amended, of Davison Township, Genesee County, Michigan is hereby amended as follows:

A readiness to serve charge shall be assessed to each user within the township connected with the water supply system shall be determined as follows:

**COMMODITY FEE**

All users shall pay \$2.93 per 100 cubic feet for all usage per month. Rates for service are applied on the date bills are rendered.

Residential users will be billed quarterly. (Bills will reflect the readiness to serve charge and commodity fee multiplied by 3).

The Township shall pay for all water used by it at the foregoing rates, except for fire hydrant service the charge shall be \$50.00 per year for each fire hydrant. Charges for services furnished by the system to any premises shall be billed and collected quarterly.

The first such charges for each premises to be due and payable on the first day of the calendar quarter following by at least one month, the date such premises are connect to the system and successive charges to be due and payable on the first day of each quarter annual period thereafter. Charges shall be billed at least fifteen (15) days before their due date.

**SECTION 2**

All other provisions of this Ordinance, including those provisions that provide penalties for the violation of this Ordinance, shall remain in full force and effect.

**SECTION 3**

This Ordinance shall take effect upon publication.
